



BOAT STORAGE - TERMS AND CONDITIONS

1. Definitions in this agreement:
 - a) "Boat" means the sea-going vessel/canoe owned or controlled by the Owner and all related accessories and accompaniments while at the Marina or VOS compound, regardless of whether in or out of the water
 - b) "VOS compound" means the rented/leased facility at which Vancouver Ocean Sports (VOS) operates its activities and includes any of the storage structures, equipment, accessories used to store, hold or transport boats while in or out of the compound
 - c) "Operator" means Vancouver Ocean Sports (VOS) and their respective officials, directors, officers, servants and agents
 - d) "Owner" means the owner(s) of the Boat and their respective officers, servants, agents, invitees and/or the parties placed in control of the Boat by the Owner
2. The Owner hereby releases and discharges the Operator from all liability for any damage to or loss of the Boat or any property stored at the VOS compound belonging to the Owner, and for any personal injury or death suffered by the Owner or by any other person on or about the VOS compound.
3. The Operator is NOT liable for loss or damages of any kind; it is highly recommended that Owners purchase property insurance sufficient to cover the replacement cost of any and all equipment stored at the VOS compound.
4. The Owner covenants to indemnify and save harmless the Operator from all loss (including all consequential economic loss), damage, injury or death caused by or arising from docking, storage, inspection, maintenance, repair, use and / or operation of the Boat.
5. The release and covenant of indemnification given herein shall apply and continue notwithstanding termination of this Agreement, breach of this Agreement by the Operator, or negligence on the part of the Operator or any of its officers, directors, employees or agents.
6. Boat Storage is non-transferable unless authorized by Vancouver Ocean Sports.
7. The annual cost of Boat Storage at the VOS compound is as follows

8. This agreement must be renewed at the end of each rental term.
9. The rental term runs from April 1st to March 31st of each year
10. **Non-payment of Boat Storage fees: Members will be given 30 days' notice to pay outstanding Boat Storage fees.** If at the end of the notice period payment in full has not been received, their boat will be impounded. Impounded boats are subject to a release fee equivalent to the current annual Boat Storage rate. To arrange the release of an impounded boat, the release fee payment must be made to VOS. Once proof of payment is received, the VOS Board will then release the boat. **Impounded boats that are unclaimed or not released within 30 days may be sold with all proceeds accruing to the Club.**
